



Invitation

We have the great pleasure to invite fly fishermen and -women from all over the Europe to **Stor-Elvdal & Rendalen Sport Fishing Festival 2019** the days from September the 5th to the 8th.

As a part of the festival we also arrange the **Norwegian Fly Fishing Championship 2019**.

There will be both an individual competition and a team competition (4 member teams). The team can also register 1 substitute for teams from Europe as a part of preparation to next year championship.

The competition is open for a maximum of 60 anglers (15 teams) from other countries than Norway.

This festival is an important part of our preparation for the 26th FIPS-Mouche European Fly Fishing Championship 2020 and hopefully the 1st FIPS-Mouche World Ladies Fly Fishing Championship 2020. And it is arranged under the rules and regulations from FIPS-Mouche – except the numbers of members of each team (4 members instead of 5 in EFFC and WLFFC), art. 11.4 There will be none official practice, and art. 31.1.a) The fishing of competition sectors by competitors or their agents during a period of 14 days prior to the official start of the event.

The competition venues will be in the same rivers and lake where the ***EFFC and WLFFC 2020 will take place from July the 6th to the 12th 2020.***

There are 4 competition sectors:

- 2 sectors in the Glomma River,
- 1 sector in the Mistra River,
- 1 sector in still water Storsjøen, with boatfishing.

The head quarter of the competition is the small town of Koppang, located by the banks of the river Glomma. And the maximum of travelling time from the head quarter in Koppang to the sectors most far away (Glomma Upper) will be approx. 30 min.

Participant fee

NOK 1990,- – each participant, which includes all necessary fishing licenses for the competition (fishing 6th and 7th) transportation during competition and lunches the competition days and closing banquet Saturday evening.

Participant fee must be paid together with the registration latest 22nd of August.

Norwegian Fly Fishing Championship and Stor-Elvdal & Rendalen Sport Fishing Festival 5th – 8th September 2019

RULE MODIFICATIONS

Glomma fiskeforening, Storsjoen fiskeforening and NKFF will host the Norwegian Fly Fishing Championship and Stor-Elvdal & Rendalen Sport Fishing Festival. This will be held in Stor-Elvdal & Rendalen Region, Norway.

These Rule Modifications apply to the [latest published FIPS-Mouche Competition Rules](#).

Article 2 : General Information

2.2. Add Three sessions will be held in river, bank fishing, wading allowed. : One session will be held in lake, boat fishing.

Article 9: Bank Fishing Competitions

9.3. Change: The beats will be an average of 100m for sector I, sector II and III, with no buffer zones.

9.4 Add: If there is an island on the beat, the controller may control from the island, to keep permanent visual contact with the competitor. He must enter the island half an hour before the start of the session; making sure not to disturb the fishing water

9.7 Add : Wading is allowed on the sectors and chest waders may be worn. The organisation recommends the use of a wading stick, to be brought by the competitors.

9.8 Add: Shuffling of the riverbed or excessive movement while wading is not allowed. The competitor must fish his/her flies minimum 2 meters from their body.

Article 10: Boat fishing competitions

10.4 Change: Boats will be launched 15 minutes before the start of the session.

10.9 add: Fishing will be from drifting boats. Drogues will be used during drifting. Eye protection (glasses) will be used, life vest will be used. Two competitors on one boat.

Competitor must bring their own life vest.

Article 11: Duration of events, scoring and practice sessions

11.3. Add: The hours for fishing will be in the program of the championship: from 08:00 to 11:00 and from 15:30 to 18:30 for Sector IV.

Sector I, II and III with 30min rotation: fishing 08:00-9:30 and 10:00-11:30/ 15:30-17:00 and 17:30-19:00. Competitors rotate 3 beats (e.g. 1 and 4, 9 and 12...)

11.4. Change: There will be none official practice.
Unofficial practice can be done outside the sectors from 22nd August to 5th September 2019.

Add - All unofficial practice and the competition will be fished with barbless hooks.

Article 23: Care of fish caught

23.1. Add: When the competitor wants to score a fish, she/ he has to make sure, that the fish is all the time submerged in the water, while bringing the fish to the controller. If it does not happen, that fish will be disallowed.

Article 25: Eligible fish

25.1. Add: Eligible fish species:

Brown Trout (*Salmo Trutta Fario*), Grayling (*Thymallus Thymallus*), Whitefish (*Coregonus Lavaretus*) and Arctic Char (*Salvelinus Alpinus*) with a minimum length of 200mm

Measuring will be done from the tip of the nose to the extremities of the tail, squeezed together.

Article 31: Prohibitions

31.1.a) Change: The fishing of competition sectors by competitors or their agents during a period of fourteen days prior to the official start of the event : no fishing from 22nd August to 5th September 2019.

Article 33: Awarding of points

33.1 Add: Points per fish : 100

33.2 Add: Points per centimetre of the fish's total length : 20

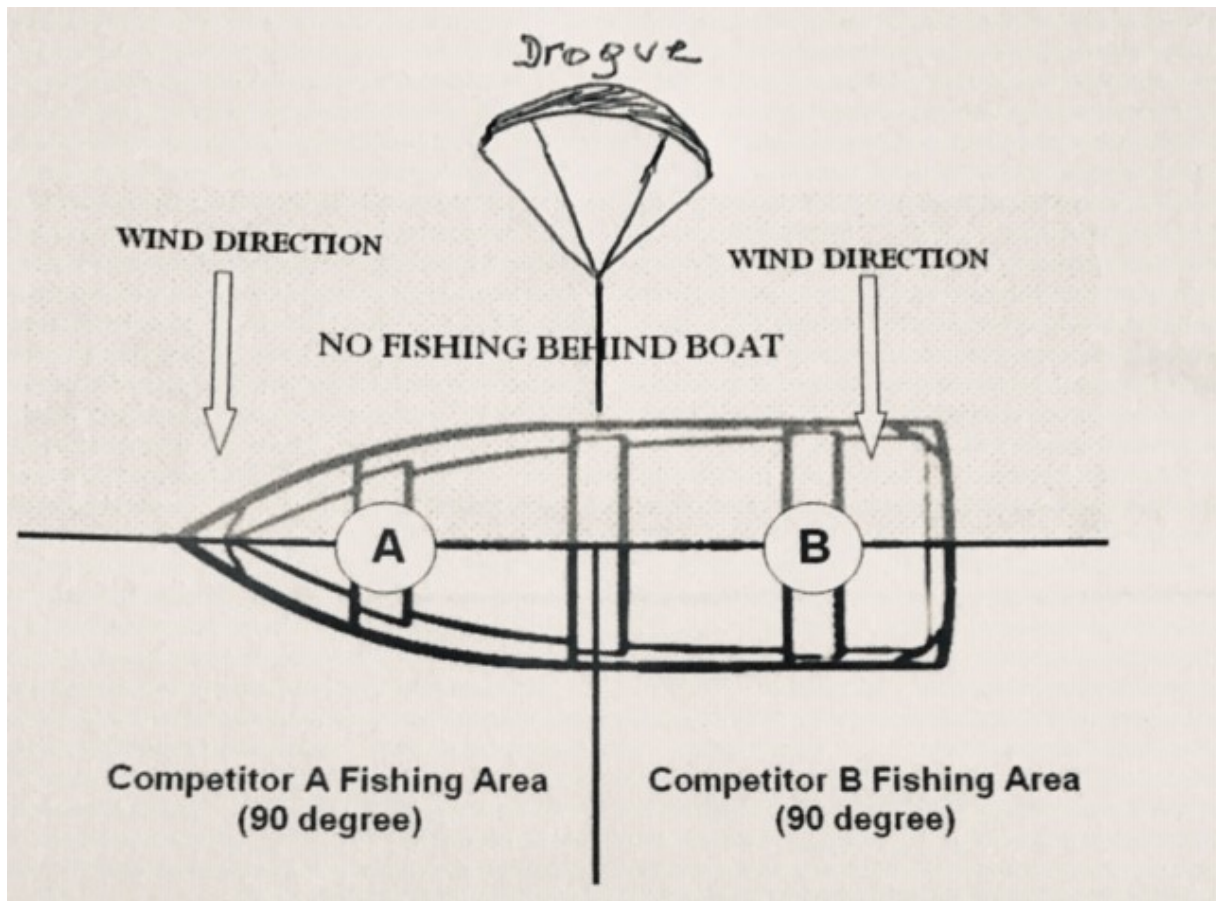

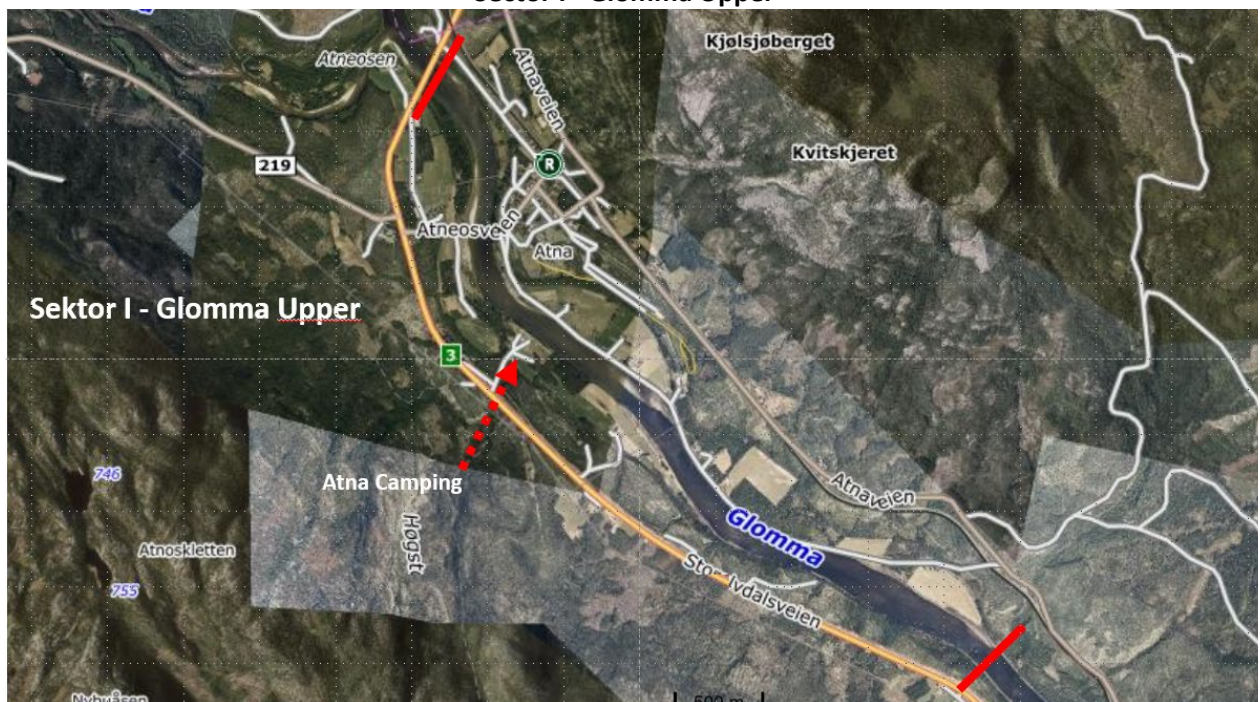

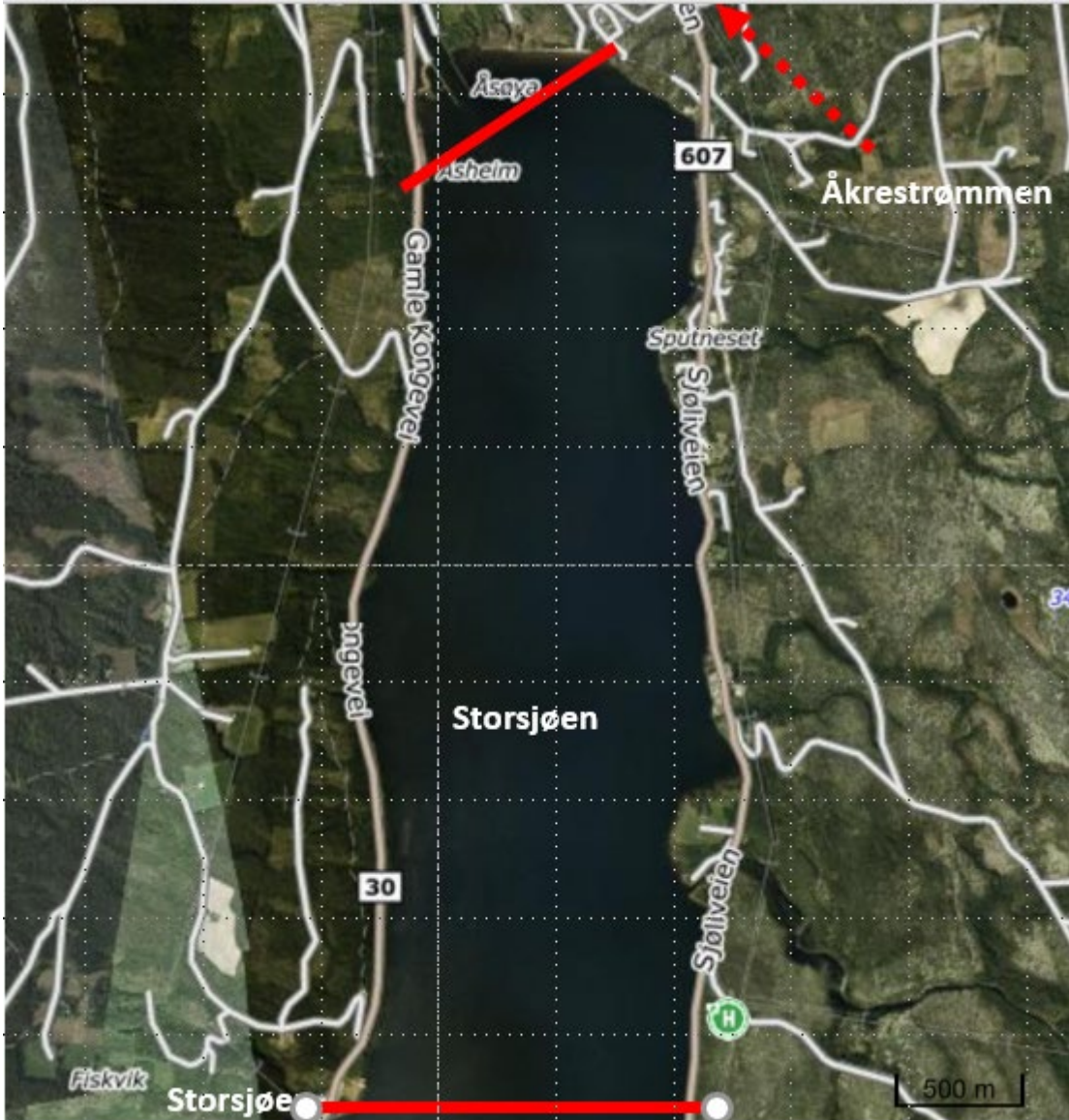
Sektor II - Glomma lower
